# 1 Introduction

## 1.1 Overview

Today, the *PostalOne!*® system provides Mailers with a service option to electronically submit postage statements and supporting documentation to the USPS® Business Mail Entry Unit. Using the *PostalOne!* system over the Internet eliminates the Mailers need to print and provide a hard copy (paper) postage statement with their mailing. There are many advantages to electronic submission of mailing information such as, streamlining the mailing process, improving accuracy of information, eliminating hard copy documentation, and enhancing the Mailers service.

On May 18, 2009, in addition to the electronic documentation (eDoc) option, the *PostalOne!* system will offer two options for using the Intelligent Mail® barcode – the basic option and full-service option. The Basic Intelligent Mail barcode will contain routing information for the delivery address but does not need to uniquely identify the mailpiece. Under the Full-Service program, Mailers must use unique Intelligent Mail barcodes on mailpieces, trays and containers, and electronically submit postage statements and mailing documentation through the *PostalOne!* system. Full-service Mailers will have three options to submit electronic mailings: Postal Wizard, Mail.dat®, and Mail.XML™. Postal Wizard submissions and Mail.dat files will be accepted in May 2009, and Mail.XML will be accepted beginning in November 2009. Mailers who qualify for the full-service option can receive certain benefits, including Start-the-Clock information and Address-Correction information for qualified letters and flats that are endorsed as specified for OneCode ACS®. In addition to these benefits, beginning in November 2009, the Postal Service® will provide lower rates to Mailers that implement the full-service option.

A Mailer can participate in eDoc with or without Intelligent Mail service. Use of eDoc is optional for basic mail; eDoc is required for full-service mail. The level of detail required for basic and full-service is more in depth than the eDoc currently supported in the *PostalOne!* system. Today, eDoc, using the Mail.dat 08-1 or 08-2, is aggregated at the package level for the generation of the Qualification Report and Postage Statement. As part of the Basic and full-service, Mailers are required to provide information for every mailpiece in their mailing except for mailings that do not require documentation to support presort. In this case, mailings of fewer than 10,000 pieces with postage affixed to each piece at the correct rate or with all identical weight pieces, the pieces are separated by rate.

On May 18, 2009, the Postal Service will make available a Test Environment for Mailers (TEM) to allow Mailers to test their ability to send eDoc information. The TEM is designed to allow Mailers to upload files to a “production-like” environment of the *PostalOne!* system. This will provide Mailers a way to test their file layouts and corresponding file submission/creation software for creating electronic submission of documentation prior to participating in the production application. The TEM environment will process the submitted files for the same validations that will be found in the production environment. It will also capture, log, and display the error information in the same manner as the production environment for the Mailers use in updating file layout and software processing.

On May 18, 2009, a new release of the Business Customer Gateway will be available on [USPS.com](http://USPS.com). The new Business Customer Gateway will create a single, unified landing point for customers to access all of the Postal Service’s online business offerings. The Business Customer Gateway will:

- Consolidate Postal Service online offerings
- Provide jumping-off point for access to all Business Services

- Provide business customers an integrated look at their USPS services
- Drive all customer Self-Service focus drives all process decisions
- Provide Self-Service Capability for Administrators to Manage their own Users
- Provides Integrated Business Profile

## 1.2 Scope

The purpose of this document is to provide the steps needed to participate in electronic documentation and/or to migrate to Intelligent Mail service. This Business Customer Gateway and the TEM are components in participating in eDoc and Intelligent Mail.

This document will cover the above-mentioned features and the steps for participation:

- eDoc
- Basic Service
- full-service

## 2 Electronic Documentation and Intelligent Mail

### 2.1 Electronic Documentation Participation Steps

#### 2.1.1 Existing *PostalOne!* Mailers Using eDoc

As part of *PostalOne!* Release 20.0.0, a new user sign-on and authentication system is being deployed. For most users, their existing *PostalOne!* username and password will continue to work in the new system. The majority of Mailers will have their account credentials migrated into the new sign-in process. Exceptions will be handled in advance. The *PostalOne!* Help Desk will contact each of these exception users prior to launch to ensure that access to the system is uninterrupted.

Mailers using the production *PostalOne!* system and needing to get started using Release 20.0 should:

1. Go to the Business Customer Gateway through [usps.com](http://usps.com).
2. Log on with your existing *PostalOne!* system username and password.
3. Update your *PostalOne!* user account.

### 2.1.2 New *PostalOne!* Mailers Wanting to Use eDoc

New *PostalOne!* Mailers who wish to submit their electronic documentation must apply for access to the *PostalOne!* system through the Business Customer Gateway.

Prior to May 18, 2009, Mailers who elect to use the Postage Wizard or Mail.dat should apply for access to the *PostalOne!* system as follows:

1. Go to <http://www.usps.com>.
2. From the homepage, browse "All Product and Services."
3. Click ***PostalOne!*** in the product list. *PostalOne!* Home Page will appear.
4. Click **New Customer**. Steps for *PostalOne!* participation will display.
5. Click **Apply Online** at the bottom of the page.
6. Complete the online application and submit for processing.

After May 18, 2009, Mailers who elect to use the Postage Wizard or Mail.dat should apply for access to the *PostalOne!* system. Applying for and obtaining access to the *PostalOne!* system is quick and easy. The application process is available online through the Business Customer Gateway at <http://www.usps.com>.

1. Follow the instructions for New Customers.
2. Click the **Manage Mailing Activity** service.
3. Complete the online process and the Mailer will be able to access TEM environment from the Business Customer Gateway landing page.

**NOTE:** All companies participating in electronic data exchange are required to accept the Terms & Conditions agreement, which details a participant's rights and responsibilities in this electronic arena.

#### 2.1.2.1 New *PostalOne!* Mailers Using eDoc With the Postal Wizard

Mailers who elect to use the Postal Wizard "Submit a Form" feature to submit their postage statement must conform to the following conditions:

- Each mailing also must be accompanied by presort and price documentation produced by PAVE™-certified or MAC™-certified software or by standardized documentation. The exception to this is for mailings of fewer than 10,000 pieces, where presort and price documentation is not required if postage at the correct price is affixed to each piece, or if each piece is of identical weight and the pieces are separated by price when presented for acceptance.
- Mailers may use a single postage statement and a single documentation report for all price levels in a single mailing.
- Standard Mail mailings prepared under the value-added refund procedures or as combined mailings must meet additional standardized documentation requirements per the Domestic

Mail Manual (DMM) [604.9.0, Refunds and Exchanges](#), and [705.5.0, First-Class Mail or Standard Mail Mailings With Different Payment Methods](#).

### **2.1.2.2 New *PostalOne!* Mailers Wanting to Use eDoc with Mail.dat**

Mailers who elect to use Mail.dat prior to May 18, 2009, must use Mail.dat version 08-1 or 08-2 to submit their electronic documentation. Mailers who elect to use Mail.dat, after May 18, 2009, must use Mail.dat version 08-1, 08-2, or 09-1 to submit their electronic documentation.

Both options require the Mailer to validate their file format and pass test criteria prior to moving to the *PostalOne!* production environment. It is the responsibility of the Business Mail Entry Unit (BMEU) or Business Mailer Support (BMS) to ensure the Mailer is properly prepared to move into the *PostalOne!* production system.

#### **Mail.dat Testing and Authorization Steps**

1. Mailers will begin transmitting Mail.dat files into the TEM environment.
2. The *PostalOne!* Help Desk will assist Mailers with the testing process, monitor that the test criteria is being completed, and provide technical assistance.
3. Once the Mailer has successfully completed their Mail.dat file testing in the TEM environment, the *PostalOne!* Help Desk will notify the BMEU or BMS that the Mailer has completed testing and is ready to move to production.
4. For Mailers with an alternate mailing agreement, there will be a parallel test process. In the parallel test, the Mailer must send to the *PostalOne!* system all Mail.dat files and postage statement updates for five consecutive business days, and during that time, the Mailer must continue to provide hard copy postage statements and hard copy documentation (or other previously approved electronic documentation). The acceptance employee must compare the hard copy document to the electronic documentation to ensure the values match.
5. In the parallel test process, the acceptance clerk must keep a copy of the hard copy postage statements, or have the original postage statements available for review at the end of the parallel run and the original hard copy documentation available at the DMU or BMEU for the authorization review.
6. In the parallel test process, BMS will perform the on-site review immediately following the five-day period.
7. BMEU or BMS will execute final approval process to go to production.
8. BMEU or BMS will notify Mailer their mailing site is approved for Production *PostalOne!*.

**NOTE:** Testing Criteria is located in Section 4 of this document.

## **2.2 Basic Participation Steps**

Under the Basic option Mailers are not required to uniquely number the mailpieces – Mailers may choose to populate the Serial Number field of the Intelligent Mail barcode with zeroes. Two options exist today for submitting electronic mailing information: the Postage Wizard and Mail.dat. These options will remain after May 18, 2009. The Postal Service will offer a third option, Mail.XML, which will be available in the November 2009. Although Mailers are not currently required to submit their mailing documentation such as postage statements and qualification reports electronically, they may choose to so under the Basic option.

## 2.2.1 Basic Preparation Steps

1. Review the guide *A Beginner's Overview to Intelligent Mail Services* available on the [ribbs.usps.gov](http://ribbs.usps.gov) website. It provides guidelines, suggestions and a comprehensive list of resources for implementing the Intelligent Mail barcode.

2. Acquire a Mailer ID.

The Mailer ID is a field within the Intelligent Mail barcodes that is used to identify Mail Owners and/or Mailing Agents. The MID is assigned by the USPS to each Mail Owner and/or Mailing Agent or other service providers.

Mailer IDs can be a nine-digit numeric or a six-digit numeric ID and are assigned based upon annual mail volume for the prior year (i.e. Jan 1-2008 - Dec 31- 2008). There is no volume requirement for a Mailer to obtain the first nine-digit MID; each subsequent MID requires a volume of one million pieces. The volume requirement to obtain six-digit MID is ten million pieces. A Mailer can obtain up to five six-digit MIDs. All requests for more than five six-digit MIDs must be submitted in writing to the Manager, Business Mail Acceptance at USPS Headquarters. All requests must contain justification for the additional MIDs and an explanation on how the MIDs will be used.

For Mailers, with no volume or the USPS is unable to validate volumes through internal systems, the USPS will provided one nine-digit MID. If the Mailer would like any additional MIDs, they will have to provide volume for at least one million pieces from the past year which can be validated by a USPS representative.

For Full-service, Mailer ID and serial number must stay unique for 45 days before it can be reused.

Prior to May 10, 2009, a Mailer can attain a Mailer ID as follows:

- a. A Mailer will contact their local BMEU or Mailpiece Design Analyst (MDA), which can be located by accessing:
  - Mailpiece Design Analyst Locator at: [http://pe.usps.gov/mpdesign/mpdfr\\_mda\\_lookup.asp](http://pe.usps.gov/mpdesign/mpdfr_mda_lookup.asp).
  - District Business Mail Entry Locator at: <http://www.usps.com/ncsc/locators/find-bme.html>.
- b. The BMEU representative or MDA will determine if the Mailer wishes to participate in OneCode® ACS or OneCode Confirm®. If a Mailer wishes to participate in OneCode ACS or OneCode Confirm, the local BMEU or MDA will refer the customer to the following numbers:
  - OneCode ACS: (877) 640- 0724 (select option 1)
  - OneCode Confirm: (800) 238- 3150
- c. A Mailer ID will be provided in the OneCode Confirm and OneCode ACS process. Customers wishing to obtain a MID, the BMEU representative or MDA will provide the MID application to the Mailer and assist them in completing the application. If a mailing agent is acting on behalf of a mail owner, the mail owner and mailing agent must read, complete, and sign section 3b of the MID application.
  - The MID Application will be forwarded to the *PostalOne!* Help Desk for processing
  - The *PostalOne!* Help Desk will notify the customer of their MID.

After May 10, 2009, Mailers can obtain their Mailer ID online by accessing the Business Customer Gateway at [www.usps.com](http://www.usps.com).

3. Design and implement IM barcode
4. Contact the local Mailpiece Design Analyst (MDA) and work with the MDA to verify the accuracy and readability of the barcode. The MDA is equipped with tools to assist Mailers to validate and test their barcodes.

**NOTE:** If a Mailer chooses to participate in submission of electronic documentation, the Mailer should precede to the step 5. If not, the Mailer has completed the necessary steps and is ready to participate in the Basic option. Also, if a Mailer is currently participating in eDoc, they have completed the necessary steps and are ready to participate in the Basic option.

5. For eDoc Participation:

Mailers who wish to submit their mailing documentation electronically must apply for access to the *PostalOne!* system.

Prior to May 18, 2009, Mailers who elect to use Mail.dat should apply for access to the *PostalOne!* system as follows:

- a. From the homepage, browse "All Product and Services."
- b. Click **PostalOne!** in the product list. The *PostalOne!* Home Page will appear.
- c. Click **New Customer**. Steps for *PostalOne!* Participation will display.
- d. Click **Apply Online** at the bottom of the page.
- e. Complete the online application and submit for processing.

After May 18, 2009, Mailers who elect to use the Postal Wizard or Mail.dat should apply for access to the *PostalOne!* system. Applying for and obtaining access to the *PostalOne!* system is quick and easy. The application process is available online through the Business Customer Gateway at <http://www.usps.com>.

- a. Follow the instructions for New Customers.
- b. Select the **Manage Mailing Activity** service.
- c. Complete the online process and the Mailer will be able to access TEM environment from the Business Customer Gateway landing page and obtain additional test criteria information.

### **2.2.1.1 Basic Option Mailers Wanting to Use eDoc with Postal Wizard**

Mailers who elect to use Postal Wizard under Submit a Form to submit their postage statement information must conform to the following conditions:

- Each mailing also must be accompanied by presort and price documentation produced by PAVE-certified or MAC-certified software or by standardized documentation. The exception is for mailings of fewer than 10,000 pieces, where presort and price documentation is not required, if postage at the correct price is affixed to each piece or if each piece is of identical weight, and the pieces are separated by price when presented for acceptance.
- Mailers may use a single postage statement and a single documentation report for all price levels in a single mailing.

- Standard Mail mailings prepared under the Value Added Refund procedures or as combined mailings must meet additional standardized documentation requirements under DMM [604.9.0, Refunds and Exchanges](#), and [705.5.0, First-Class Mail or Standard Mail Mailings With Different Payment Methods](#).

### **2.2.1.2 Basic Option Mailers Wanting to Use eDoc with Mail.dat**

Mailers who elect to use Mail.dat prior to May 18, 2009, must use Mail.dat version 08-1 or 08-2 to submit their electronic documentation. Mailers who elect to use Mail.dat, after May 18, 2009, must use Mail.dat version 08-1, 08-2, or 09-1 to submit their electronic documentation.

Both options require the Mailer to validate and pass the file format test criteria prior to moving to the Production *PostalOne!* system. It is the responsibility of the Business Mail Entry Unit (BMEU) or Business Mailer Support (BMS) to ensure the Mailer is properly prepared to move into the Production *PostalOne!* system.

#### **Mail.dat Testing and Authorization Steps**

1. Mailers will begin transmitting Mail.dat files into the TEM environment.
2. The *PostalOne!* Help Desk will assist Mailers with the testing process, monitor that the test criteria is being completed, and provide technical assistance.
3. Once the Mailer has successfully completed their Mail.dat file testing in the TEM environment, the *PostalOne!* Help Desk will notify the BMEU or BMS the Mailer has completed the file testing and ready to move to P1 production.
4. For Mailers with an alternate mailing agreement, there will be a parallel test process. In the parallel test, the Mailer must send to the *PostalOne!* system all Mail.dat files and postage statement updates for five consecutive business days, and during that time the Mailer must continue to provide hardcopy postage statements and hardcopy documentation (or other previously approved electronic documentation). The acceptance employee must compare the hardcopy document to the electronic documentation to ensure the values are matching.
5. In the parallel test process, the acceptance clerk must keep a copy of the hardcopy postage statements or have the original postage statements available for review at end of parallel run and the original hard copy documentation available at the DMU or BMEU for the authorization review.
6. In the parallel test process, BMS will perform the on-site review immediately following the five-day period.
7. BMEU or BMS execute final approval process.
8. BMEU or BMS will notify Mailer their mailing site is approved for Production *PostalOne!*

**NOTE:** Testing Criteria is located in Section 4 of this document.

## **2.3 Full-Service Participation Steps**

Under the full-service option, electronic documentation must be used to transmit data files for generating postage statements and mailing documentation to the Postal Service's *PostalOne!* System. These files describe how mailpieces are linked to trays or sacks, and to containers (if applicable), and are required to match the preparation of the mail to qualify for the full-service option.

### 2.3.1 Preparation Steps

1. Review the guide, *A Beginner's Overview to Intelligent Mail Services*, available on the [ribbs.usps.gov website](http://ribbs.usps.gov). It provides guidelines, suggestions and a comprehensive list of resources for implementing the Intelligent Mail barcode.

2. Acquire a Mailer ID

The Mailer ID is a field within the Intelligent Mail barcodes that is used to identify Mail Owners and/or Mailing Agents. The MID is assigned by the USPS to each Mail Owner and/or Mailing Agent or other service providers.

Mailer IDs can be a nine-digit numeric or a six-digit numeric ID and are assigned based upon annual mail volume for the prior year (i.e. Jan 1-2008 - Dec 31- 2008). There is no volume requirement for a Mailer to obtain the first nine-digit MID; each subsequent MID requires a volume of one million pieces. The volume requirement to obtain six-digit MID is ten million pieces. A Mailer can obtain up to five six-digit MIDs. All requests for more than five six-digit MIDs must be submitted in writing to the Manager, Business Mail Acceptance at USPS Headquarters. All requests must contain justification for the additional MIDs and an explanation on how the MIDs will be used.

For Mailers, with no volume or the USPS is unable to validate volumes through internal systems, the USPS will provided one 9-digit MID. If the Mailer would like any additional MIDs, they will have to provide volume for at least one (1) million pieces from the past year, which can be validated by a USPS representative.

For full-service, the Mailer ID and serial number must stay unique for 45 days before it can be re-used.

Prior to May 10, 2009 a Mailer can attain a Mailer ID as follows:

- a. A Mailer will contact their local BMEU or Mailpiece Design Analyst (MDA), which can be located by accessing:
  - Mailpiece Design Analyst Locator at: [http://pe.usps.gov/mpdesign/mpdfr\\_mda\\_lookup.asp](http://pe.usps.gov/mpdesign/mpdfr_mda_lookup.asp).
  - District Business Mail Entry Locator at: <http://www.usps.com/ncsc/locators/find-bme.html>.
- b. The BMEU representative or MDA will determine if the Mailer wishes to participate in OneCode ACS or OneCode Confirm. If a Mailer wishes to participate in OneCode ACS or OneCode Confirm, the local BMEU or MDA will refer the customer to the following numbers:
  - OneCode ACS: (877) 640- 0724 (select option 1)
  - OneCode Confirm: (800) 238- 3150
- c. A Mailer ID will be provided in the OneCode Confirm and OneCode ACS process. Customers wishing to obtain a MID, the BMEU representative or MDA will provide the MID application to the Mailer and assist them in completing the application. If a mailing agent is acting on behalf of a mail owner, the mail owner and mailing agent must read, complete, and sign section 3b of the MID application.
  - The MID Application will be forwarded to the *PostalOne!* Help Desk for processing.
  - The *PostalOne!* Help Desk will notify the customer of their MID.

After May 10, 2009, Mailers can obtain their Mailer ID online by accessing the Business Customer Gateway at <http://www.usps.com>.

3. Design and implement IM barcodes.
4. Contact the local Mailpiece Design Analyst (MDA) and work with the MDA to verify the accuracy and readability of the barcode. The MDA is equipped with tools to assist Mailers to validate and test their barcodes.

**NOTE:** If a Mailer chooses to participate in the submission of electronic documentation, the Mailer should precede to the step 5. If not, the Mailer has completed the necessary steps and is ready to participate in the Basic option. ### **2.3.1.1 Full-Service Mailers Wanting to Use eDoc with Postal Wizard**

Mailers who elect to use Postal Wizard under "Submit A Form" to submit their postage statement information must conform to conditions specified in the Postal Wizard eDoc in section 2.1 Basic Service Participation Steps of this document.

Mailers who elect to use Postal Wizard under Submit A Form to submit their postage statement information must conform to the following conditions:

A complete postage statement must accompany each mailing. Each mailing also must be accompanied by presort and price documentation produced by PAVE-certified or MAC-certified software or by standardized documentation. The exception is for mailings of fewer than 10,000 pieces, where presort and price documentation is not required if postage at the correct price is affixed to each piece, or if each piece is of identical weight and the pieces are separated by price when presented for acceptance. Mailers may use a single postage statement and a single documentation report for all price levels in a single mailing. Standard Mail mailings prepared under the Value Added Refund procedures or as combined mailings must meet additional standardized documentation requirements under [604.9.0, Refunds and Exchanges](#), and [705.5.0, First-Class Mail or Standard Mail Mailings With Different Payment Methods](#).

### **2.3.1.2 Full-Service Mailers Wanting to Use eDoc with Mail.dat**

Mailers who elect to use Mail.dat must use Mail.dat version 09-1 to submit their electronic documentation.

### **Mail.dat Testing and Authorization Steps**

1. Mailers will begin transmitting Mail.dat files into the TEM environment.
2. The *PostalOne!* Help Desk will assist Mailers with the testing process, monitor that the test criteria is being completed, and provide technical assistance.
3. Once the Mailer has successfully completed their Mail.dat file testing in the TEM environment, the *PostalOne!* Help Desk will notify the BMEU or BMS the Mailer has completed testing and ready to move to production.
4. For Mailers with an alternate mailing agreement, there will be a parallel test process. In the parallel test, the Mailer must send to the *PostalOne!* system all Mail.dat files and postage statement updates for five consecutive business days, and during that time the Mailer must continue to provide hardcopy postage statements and hardcopy documentation (or other previously approved electronic documentation). The acceptance employee must compare the hardcopy document to the electronic documentation to ensure the values are matching.
5. In the parallel test process, the acceptance clerk must keep a copy of the hardcopy postage statements or have the original postage statements available for review at end of parallel run and the original hard copy documentation available at the DMU or BMEU for the authorization review.
6. In the parallel test process, BMS will perform the on-site review immediately following the five-day period.
7. BMEU or BMS will execute final approval process to go to production.
8. BMEU or BMS will notify Mailer their mailing site is approved for Production *PostalOne!*.

**NOTE:** Testing Criteria is located in Section 4 of this document.

All Mailers will be using the Test Environment for Mailers to test their Intelligent Mail files for full-service. Specifics for testing the TEM environment are described in the Section 3, Mail.dat Transition Strategy.

## 3 Mail.dat Transition Strategy

### 3.1 Mail.dat Overview

On May 18, 2009, the *PostalOne!* 20.0 Release will support Mail.dat version 09-1. The *PostalOne!* system will continue to support Mail.dat versions 08-1 and 08-2. The *PostalOne!* 20.0 Release includes a new file upload process designed to improve the capacity and reliability of the file upload process. Initially, the new upload process will support Mail.dat 09-1 only. The *PostalOne!* system will continue to support Mail.dat 08-1 and 08-2, through the existing Transfer Applet or Batch Processor.

The new *PostalOne!* system file upload process is accessed by downloading a single application that can be run from a Mailer's workstation or server. This application replaces both the existing Mail.dat Transfer Applet and Batch Processor software used for Mail.dat 08-1 and 08-2. Mailers using Mail.dat 08-1, 08-2 and 09-1 have the option to use both file upload processes. The new file upload process represents a reengineering of the way that files are validated and then transmitted to the *PostalOne!* system. Rather than being an update to the existing *PostalOne!* file upload process, the new file upload application represents an entirely new process for transferring data.

**NOTE:** Please refer to *PostalOne! Mail.dat Technical Guide Version 20.0* for technical specifications.

Regardless of transmitting jobs through the existing Mail.dat 08-1 or 08-2 application or the new Mail.dat 09-1 application, all jobs will be available for review on the existing the *PostalOne!* system dashboard. The new *PostalOne!* system file upload process for the Mail.dat 09-1 exists in parallel with the existing process for Mail.dat 08-1 and 08-2. The new process consists of a single, downloadable application that handles both manual and automated file transfers. The file upload process for Mail.dat 09-1 also represents a reengineered upload server designed to increase upload capacity and improve reliability.

On May 18, 2009 after the launch of *PostalOne!* Release 20.0, the Postal Service will make available a Mailer Test Environment (TEM). The TEM is designed to allow Mailers to upload files to a “production like” environment of the *PostalOne!* system. This environment will support Mail.dat Versions 08-1, 08-2, and 09-1. This environment will be integrated with the login procedures for *PostalOne!*, allowing Mailers to use the same username and password for the TEM and the *PostalOne!* system. The TEM environment will support both the existing Mail.dat Transfer Applet or Batch Processor, and the new file upload infrastructure.

The TEM environment will process the submitted files for the same validations that will be found in the production environment. It will also capture, log and display the error information in the same manner as the production environment for the Mailers use in updating file layout and software processing. As a Mail.dat job is submitted to the TEM environment, the files will be processed in the same manner as in the production environment. The system will process each submitted file and loop through all applicable validations, while capturing errors for failed validations, until all validations within all files have been processed.

The system will then store the error information for the job and log any application error information to a given log file for use by the Mailers. The system will determine if the job should be failed or processed as successful based on the severity of the captured errors. Mailers will have up to 30 days to view the validation history results within the certification environment (for testing and software configuration purposes).

### 3.2 Mail.dat Scenarios for *PostalOne!* Release 20.0




Figure 3-1. Sample Batch Processor Configuration for All File Versions

## 4 Mail.dat Testing Criteria

### 4.1 Testing Criteria for Presort

#### First Class & Standard

Scenario P1: The Mailer must be able to submit a Mail.dat file that contains the necessary information to create a Qualification Report and Postage Statement. The following reports must be successfully generated to support the Postage Statement:

- Version summary report
- Reconciliation Report
- Container and Bundle Report

Scenario 2: The Mailer must be able to submit a Mail.dat file that provides the necessary information to create a Qualification Report and Multiple (at least 2) Postage Statements, and reports specified in Scenario P1. The Mailer must be able to submit a Mail.dat that Cancels a Postage Statement.

Scenario 3: The Mailer must be able to submit a Mail.dat file that provides the necessary information to create a Qualification Report and Postage Statement and reports specified in Scenario P1. The Mailer must be able to submit a Mail.dat that Cancels a Postage Statement. Next, the Mailer must be able to submit Mail.dat that changes the piece weight and creates a Postage Statement with the new piece weight.

### Periodicals

Scenario S1: The Mailer must be able to submit a Mail.dat file that contains the necessary information to create a Qualification Report Postage Statement. The following additional reports must be successfully generated to support the Postage Statement:

- Add Percent Worksheet
- Outside County Report
- Container and Bundle Report

Scenario S2: **CPP Mailers:** The Mailer must be able to submit a Mail.dat file that contains the necessary information to create a Qualification Report and Postage Statement. The following additional reports must be successfully generated to support the Postage Statement:

- Add Percent Worksheet
- Outside County Report
- Container and Bundle Report
- Optional Payment Request

## 4.2 Testing Criteria for MLOCR (First Class & Standard)

Scenario M1: For Multi-Line Optical Character Reader (MLOCR) mailings, the Mailer must be able to submit a Mail.dat file that contains the necessary information to create a Qualification Report and Master Postage Statement. The following reports must be successfully generated to support the Postage Statement:

- Customer Mail Report
- Summary Zip Destination Report
- Reconciliation Report
- Postage Statement Summary Report

Scenario M2: The Mailer must be able to submit a Mail.dat file that provides the necessary information to create a Qualification Report and Master Postage Statement, and reports specified in Scenario M1. The Mailer must be able to submit a Mail.dat that Cancels a Postage Statement.

## 4.3 Testing Criteria for Manifests (First Class & Standard)

Scenario MF1: The Mailer must be able to submit a Mail.dat file that contains the necessary information to create a Qualification Report and Postage Statement. The following reports must be successfully generated to support the Postage Statement:

- Version Summary Report
- Reconciliation Report

#### 4.4 Testing Criteria for OnePass (First Class & Standard)

Scenario O1: The Mailer must be able to submit a Mail.dat file that contains the necessary information to create a Qualification Report and Master Postage Statement. The following additional reports must be successfully generated to support the Postage Statement:

- Summary ZIP Destination Report
- Postage Statement Summary Report
- Tray Difference Report
- Customer Mail Report
- Reconciliation Report
