Dear ACS™ Participant:

In November 2012, the U.S. Postal Service® announced new prices and product features for domestic and international mailing services. The new prices take effect January 27, 2013. The address correction fees associated with your participation in ACS will also be affected. For your planning purposes, we are providing the enclosed pricing chart showing the electronic and automated address correction fees for ACS notices before and after January 27, 2013.

The enclosed chart lists fees for both Traditional ACS and OneCode ACS®. Traditional ACS is available for all mail classes and shapes. It is the original version of ACS and has a history that goes back to the mid-1980s. OneCode ACS is available for First-Class Mail®, Standard Mail®, and Periodicals flats and letters. Full Service ACS provided for Full Service qualified mail is still free.

OneCode ACS and Full Service ACS fees for letter mail are lower than the traditional ACS fees due to automation. If you have already applied for, or are currently using OneCode ACS or Full Service ACS, then you have already recognized the benefits. If you have not yet converted to the Intelligent Mail® barcode (IMb) and Full Service or OneCode ACS, we encourage you to visit these websites for more information on how to start using the IMb:
