Using a certified software version enables the mailer to meet the new IMpb and data submission requirements:

1. **Electronically submit a Shipping Services File with manifest, tracking, and postage information in one file (through the Electronic Verification System - eVS[®])**
 - Submission is one file which includes the Shipping Services File (with destination delivery address or ZIP+4 and Destination Delivery Point Code information) and postage information
 - Payment for postage is deducted from a centralized electronic postage payment account (a Centralized Account Processing System – CAPS account)

Certified Software will meet the IMpb compliance requirements:

You have several tools to help you meet the IMpb and data submission requirements:

1. Become an eVS mailer (visit <https://ribbs.usps.gov/index.cfm?page=evs>)
2. Use a certified vendor software solution (listed on the following page)

Precertified Software for eVS:

All commercial packages are required to submit their mailing information electronically using a file referred to as a Shipping Services File. The Shipping Services File must be version 1.6 or higher, be submitted prior to presenting a shipment, and it is required that any mailer who ships to APO/FPO or International use either version 1.7 or 2.0. Not all certified software versions support all mail classes and shipping options, please use reference on the following page to select solutions that will meet your future shipping needs
